

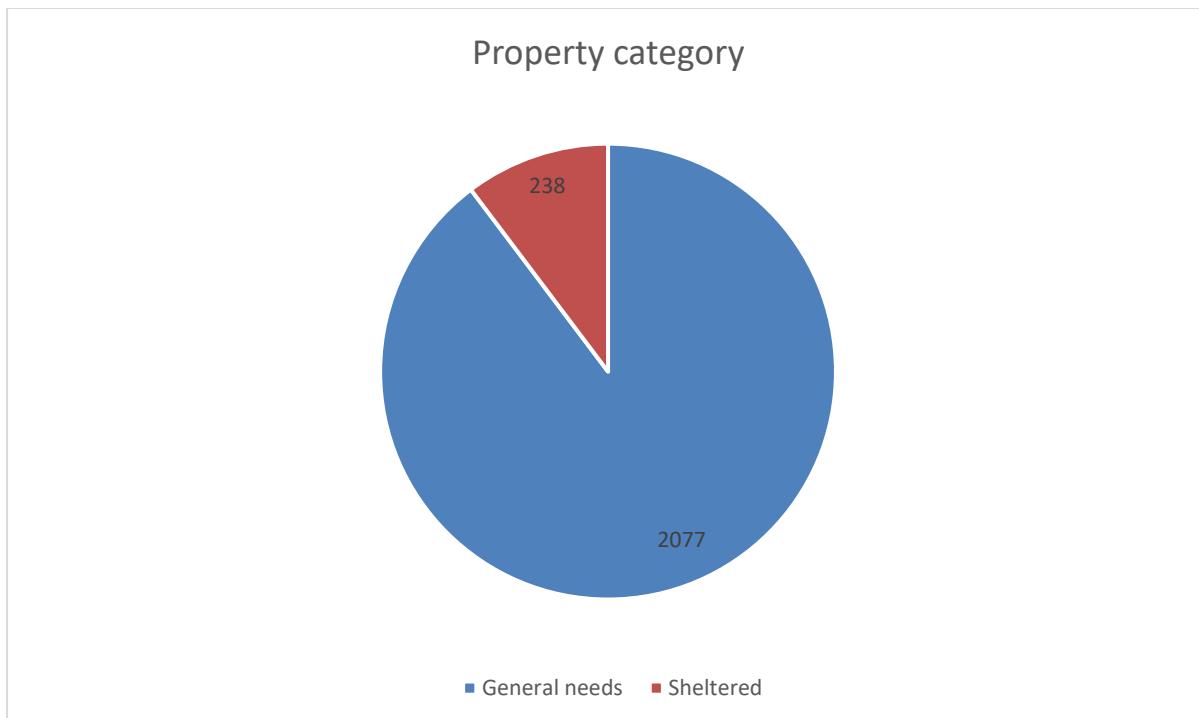
# East Herts Quarterly Housing Monitor

## 1<sup>st</sup> January – 31 March 2025

### The Housing Register

#### Applications

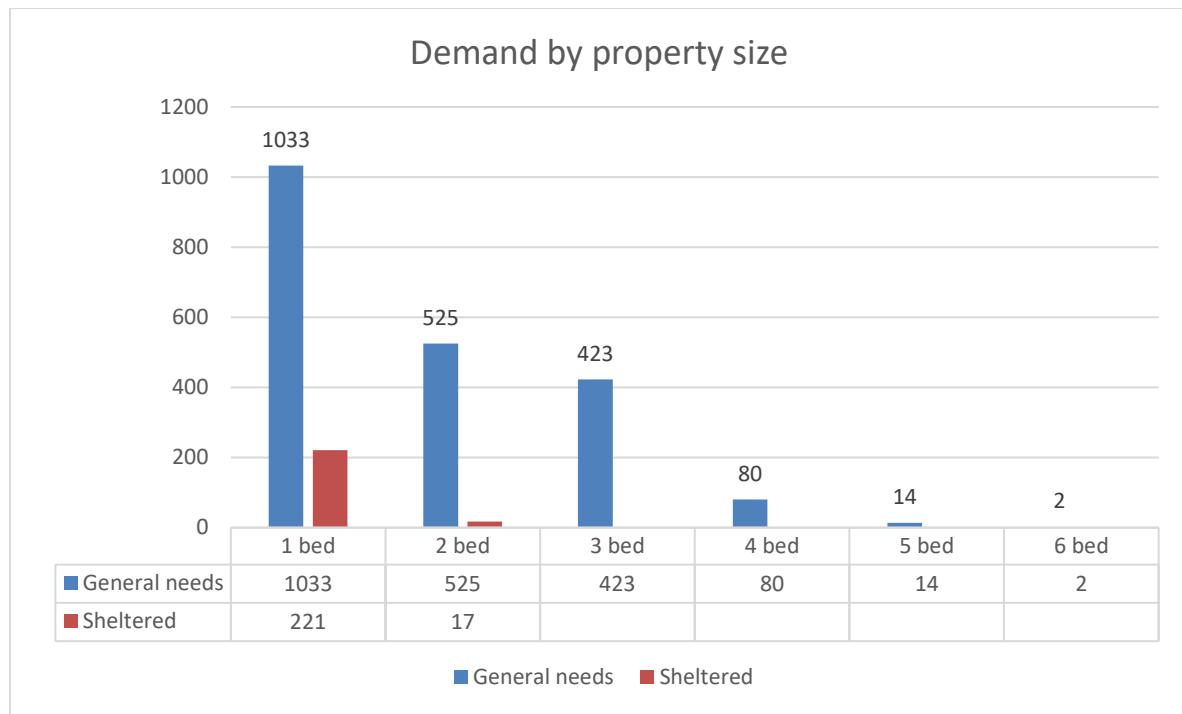
The Housing Register includes applicants for general needs and sheltered housing. On 31<sup>st</sup> March 2025, there were 2,315 live applications on the housing register. Of these, 2,077 require general needs housing and 238 require sheltered accommodation.



Of the 2,315 households on the East Herts Housing Register, 618 (27%) are currently in a social housing tenancy in the district and seeking a transfer.

#### Property size

The greatest demand is for smaller properties. Over half of all households require a 1 bed property, (50% of general needs applicants and 93% of sheltered applicants), and 23% require a 2 bed property (25% of general needs applicants and 7% of sheltered applicants).



## Allocations

Between 1<sup>st</sup> January and 31<sup>st</sup> March 2025, 151 households received an allocation of affordable rented housing. Of these, 132 (87%) were allocated to general needs housing and a further 19 (13%) households accepted an offer of sheltered housing.

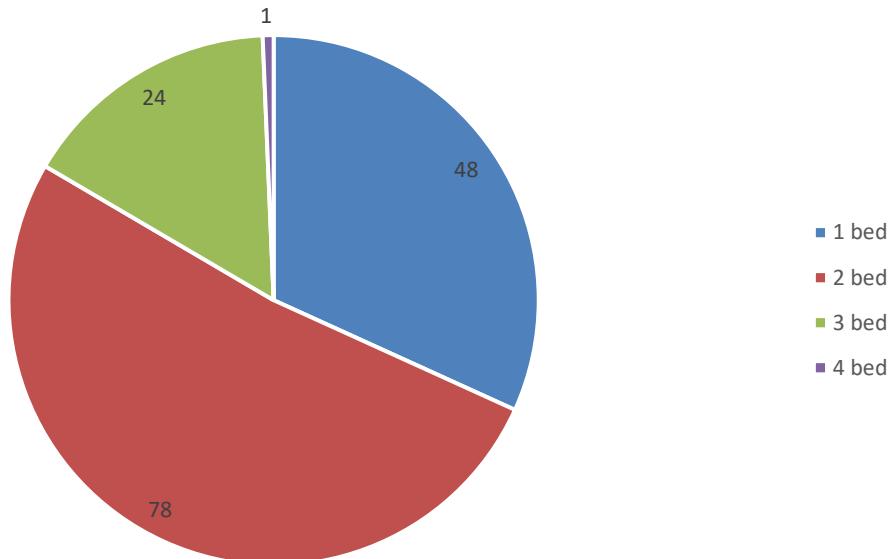
Of those allocated, 36 (24%) moved from another social housing tenancy in East Herts.

Eighteen households who received an allocation did not have a connection to the district through residence, work, family or being owed the main housing duty under homelessness legislation. Of these, 13 received an allocation to a general needs property and five to sheltered housing.

## Property size

Allocations to one bed properties accounted for 16% (24) of all allocations, two bed properties 52% (78), three bed properties 32% (48) and four bed properties 0.6% (1).

### Allocations by property size

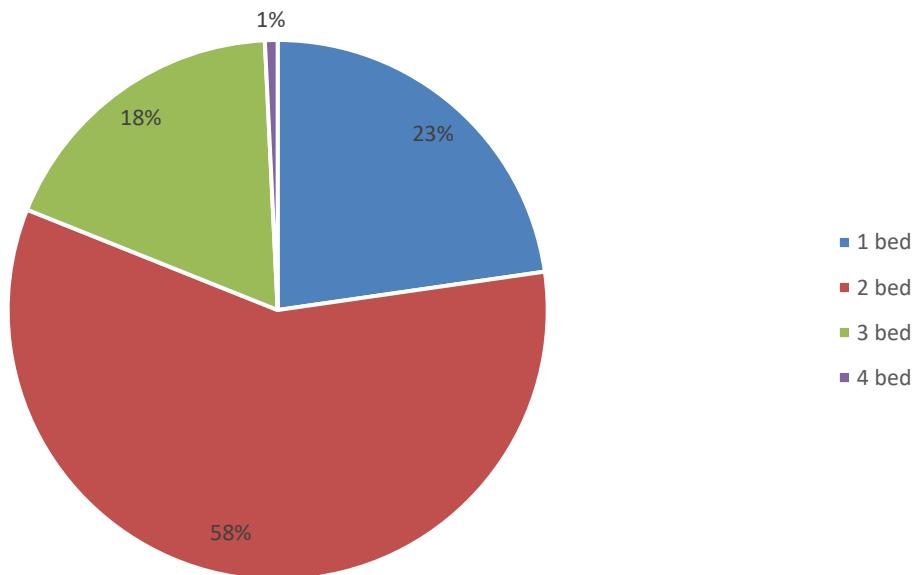


### General needs housing

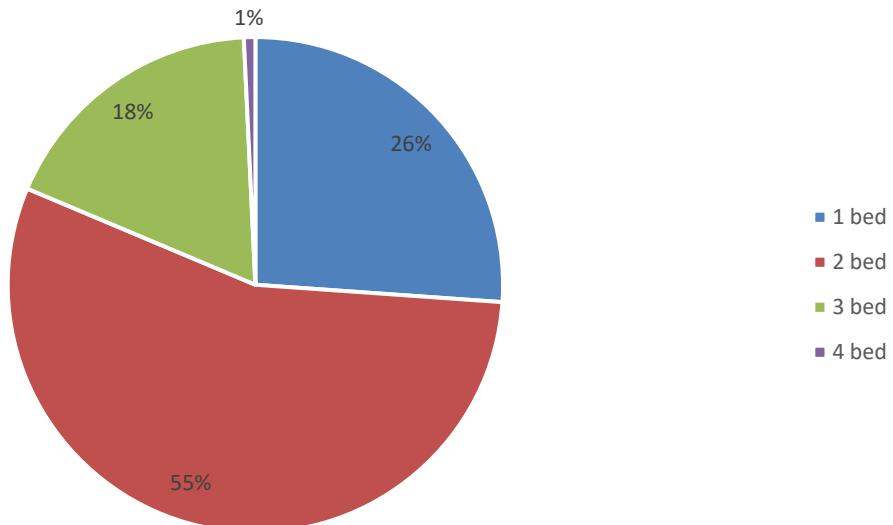

Eighty-seven percent (132) of all allocations were to general need housing. Of these, 23% (30) households were allocated to 1 bed general needs properties, 58% (77) to two bed properties, 18% (24) to three bed properties and 1% (1) to 4 bed properties.

### Allocations by property size: general needs



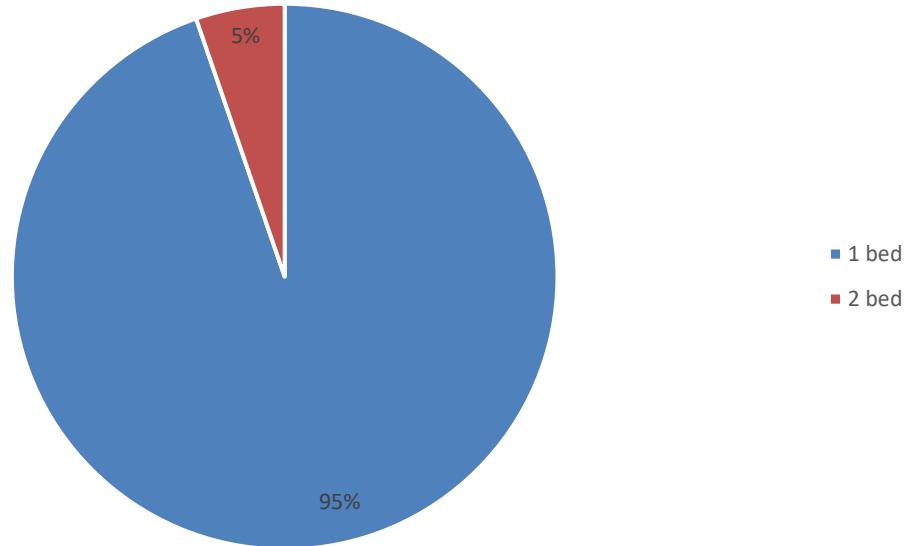
Allocations by property size: general needs



### **Sheltered housing**

Thirteen percent (19) of all allocations were to sheltered housing. Of these 95% (18) were allocated to a one bed property and 5% (1) to a two bed property.

## Average points required for an allocation

Applicants to the housing register are awarded points according to their housing need and the strength of their connection to the district. The table below shows the average points of households allocated to a property between 1<sup>st</sup> January and 31<sup>st</sup> March 2025, by property category and size.

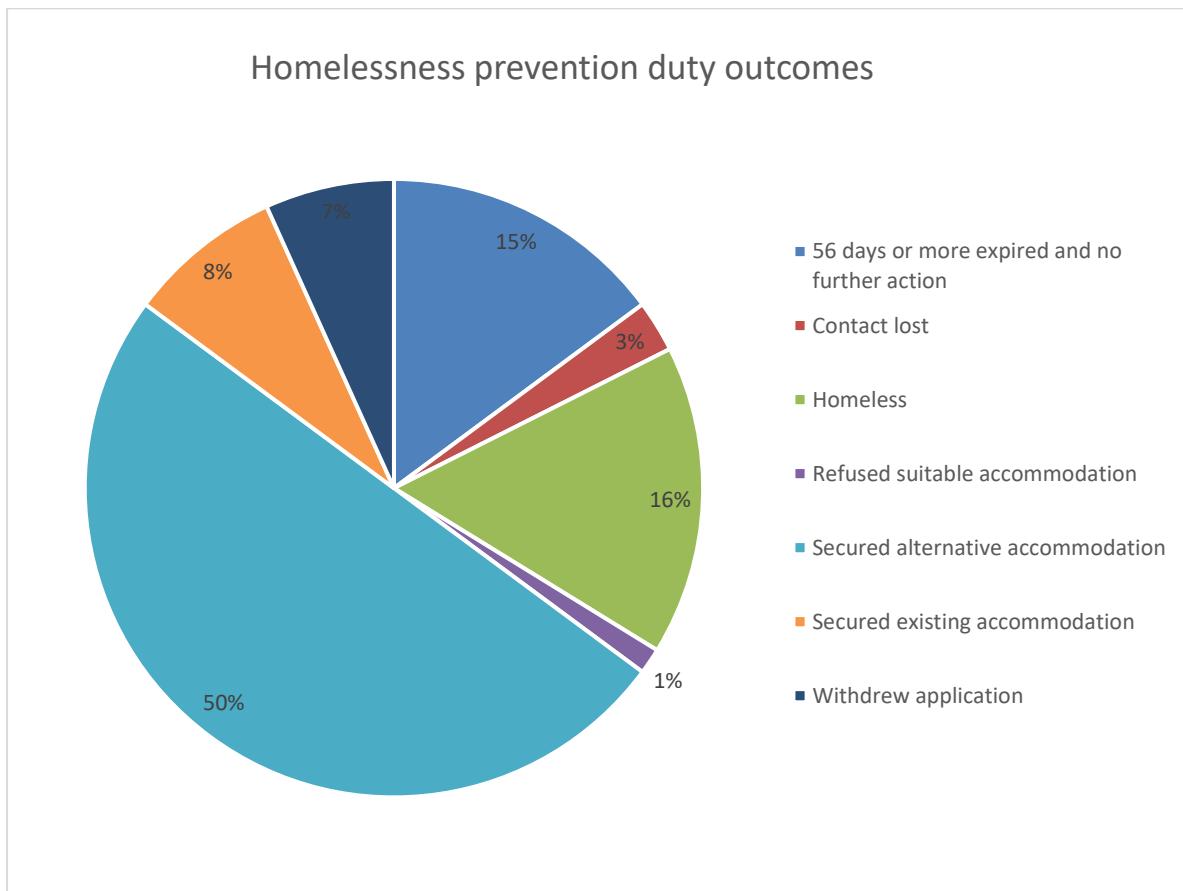
# Homelessness and housing advice

## Presentations

Between 1<sup>st</sup> January and 31<sup>st</sup> March 2025, 454 households approached the homelessness service for advice and assistance. The service carried out 223 assessments to determine whether a duty was owed under the homelessness legislation. Overall, 176 households were assessed as owed a duty, 97 were threatened with homelessness and owed the prevention duty and 79 were homeless and owed the relief duty.

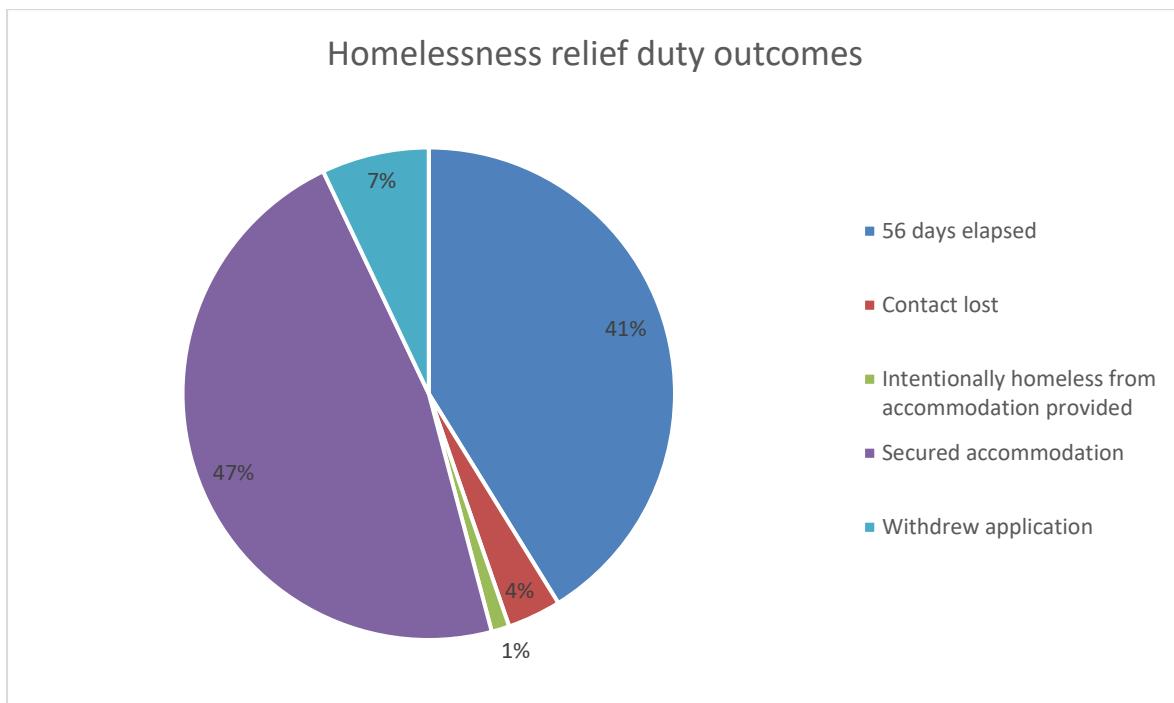
## Homelessness prevention outcomes

Over the quarter 74 prevention cases were closed. Of these, 16% (12) became homeless and owed the relief duty, 50% (37) had their homelessness prevented through securing alternative accommodation and 8% (6) were able to remain in their existing accommodation.



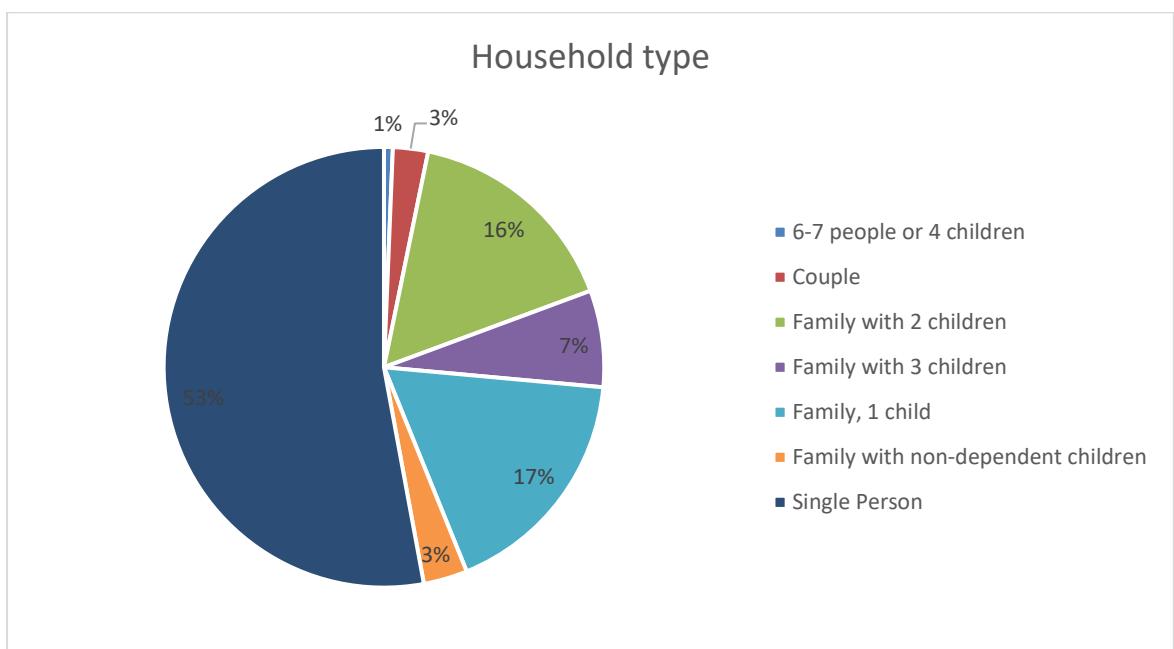
## Homelessness relief outcomes

Of the 85 relief cases closed during the quarter, 41% (35) of households remained homeless at the end of the relief duty and 47% (40) had their homelessness relieved through securing alternative accommodation.



## Household type

Of the 155 households for which the prevention and/or relief duties ended during the quarter, 41% (64) included dependent children.



## Reason for homelessness or threat of homelessness

The most prevalent reasons for households presenting as homeless or threatened with homelessness are, domestic abuse victim (22%) loss of an assured shorthold tenancy in the private rented sector (21%) family no longer willing or able to continue to accommodate the household (21%).

# New-build affordable housing

The council recognises the need for more affordable housing to meet the needs of local people. We work with developers and housing associations to deliver good quality affordable homes for rent and shared ownership.

Between 1<sup>st</sup> January and 31<sup>st</sup> March 2025, 34 new homes for rent and 19 for shared ownership were delivered in East Herts.

## Pipeline of new build affordable housing

It is anticipated that between 1<sup>st</sup> April and 30<sup>th</sup> June 2025, up to 68 homes for affordable rent and a further 66 for shared ownership will be delivered across the district.
